



TRANSFORMATIONS OF THE PUBLIC ADMINISTRATION AND PUBLIC LAW IN THE NATIONAL AND EUROPEAN SPACE AFTER 1989

25 – 26 October 2019

The year of 1989, often named *The Year of the Miracles*, led to the liberation of the Eastern European nations from the communist regime. But the liberation of those nations painted a grey reality, which pointed the contrast of the two parts of the continent. From the beginning, those states engaged on the path of democratization, of the efficient governance, where citizens become partners of the political and administrative bodies. The transformation of the societies led to adopting new legal norms, new institutions, new public policies, that need to be evaluated, 30 years after, in order to asses their impact and to learn valuable lessons.

The Conference traditionally gathers experts in the field of public law and administrative sciences – academics, legal practitioners, civil servants – the scientific event being a forum of debate and analysis of the new research directions.

This year we will try to reflect on the following aspects:

- 1. Which are the challenges for the public administration and the public law after 1989?
- 2. Which were the strategic, normative and jurisprudential trends for the administrative fields at national and European level?
- 3. Which are the innovations in the administrative field and which are the most significant administrative best practices?
- 4. What evolution to be expected in the field of public law and administrative sciences?
- 5. Which are the appropriate public policies to answer the transformations of the public administration and public law?

Publication of the scientific papers: all the accepted papers will be included in one of the publications of the conference, either in volume (book) published at Wolters Kluwer, either in one of the internationally indexed partner Journals. For the international participants, a hard copy of the volume or of the Journal will be sent by post, free of charge.

Important dates: 1st October submitting the registration form, 14th October sending the full text of the scientific paper in English, 21st October confirmation of the scientific papers to be presented at the conference.

Languages: English and Romanian

Participation and publication fee: The participation at the conference and the publication of the scientific paper in volume (book) or in one of the internationally indexed partner Journals is free of charge.
